

A.A.E. Marching Knights Band
Walt Disney World Trip / April 12 – 17, 2010
Payment Plan and Agreement / Revised Nov. 1, 2009

In this agreement, “student” refers to band members, “parent” refers to parent OR legal guardian, and “WDW” refers to Walt Disney World Resort.

1. All outstanding band fees must be paid in full by November 2 in order for the student to participate in the WDW trip.
2. A non-refundable deposit of \$300.00 must be received from each student no later than noon on November 2 in order to confirm and hold a spot on the WDW trip. Students who later opt out of the trip or fail to make payment deadlines will forfeit their deposit.
3. It is the student’s responsibility to make sure that all booster and/or donated funds are delivered to Mr. Sockwell by payment due dates.
4. All parents and students participating in the WDW trip will be included in both the airline and hotel package as determined by A.A.E. Staff. No upgrades will be offered. ALL students must stay at the same resort hotel.
5. Included in the full price is: (a) Economy airfare from Ontario to Orlando and return. (b) Hotel accommodations for 5 nights at one of Disney’s value resorts, to be determined by Disney. (c) 5 day park-hopper ticket (d) transportation expenses on the day of our performance (for band members ONLY.)
6. Students are responsible for their own transportation to and from Ontario Airport, and for all meals while on the trip.
7. Students will be allowed no more than one (1) piece of check-in luggage that meets airline specifications and maximum weight. Smaller instruments will be carried on the plane. Larger instruments will be checked at no expense to the band member.
8. If there is a surplus after a student has made his/her final payment, it will go towards meal tickets. Meal tickets may also be purchased no later than February 15 at the cost of \$14.00 per counter service meal, and \$11.00 per breakfast (prices subject to change by Disney.)
9. If a sufficient number of deposits (34) are not received by November 2, the trip will be cancelled and all payments refunded.

For non-chaperone parents and family members:

1. A total of **20** rooms are reserved for our group at Disney’s All Star Music Resort.. Any rooms not used by band members or chaperones will be released to parents on a first-payed basis
2. Parents and family members may opt to book rooms on their own. However, ALL band members must pay for the total \$800.00, even if they are included in their parent’s package deal. It is highly recommended that those booking their own rooms do not buy packages, but book a “room only.”
3. A non-refundable deposit of \$400.00 is due for the first parent, and \$300.00 from each additional family member up to 4 no later than noon on November 2 in order to confirm and hold a spot on the WDW trip
4. Items 4 through 8 above also apply to parents and family members.
